

# CBRC Retreat Cancellation Policy

## Payment Terms

### PAYMENT DETAILS

A **minimum non-refundable deposit of \$500** is required to secure your place at any of the CBRC Health & Fitness Wellness Retreats. You may choose to pay the full amount at the time of booking. If you prefer, a payment plans with three (3) installments plus the deposit are available for our retreats.

### CANCELLATIONS

1. **12+ weeks prior to the the Wellness Retreat Start Date (*November 29, 2024*): The deposit is non-refundable. If you have already paid the full fee, you will receive a refund minus the \$500 non-refundable deposit**
2. **6 - 12 weeks prior to the Wellness Retreat Start Date (*November 30, 2024 - January 10, 2025*):** This deposit is non-refundable. If you have already paid the full fee, you will receive a full refund minus a 30% admin fee. There is no refund for the 30% deposit at this stage. You can choose to reschedule your Retreat to another Retreat date, without Penalty.
3. **6 weeks prior to the Wellness Retreat start date (*January 11, 2025*): The booking at this stage is non-refundable** and cannot be transferred to another date.

**Get in touch early if you need to cancel for whatever reason.** We will do our best to re-sell your place, which we have a better chance doing if you let us know as soon as possible. If we are able to resell your place, we will be more than happy to give you a refund from the full amount paid, minus the non-refundable \$500 deposit.

**We recommend that you purchase travel insurance!** Even for domestic travel within the United States, it's best to be prepared. Travel insurance will protect you if you need to cancel within 30-days of the retreat so you can recover your financial investment (depending upon the insurance you purchase), hence avoiding or at least, easing the disappointment of having to miss the retreat.

### Refunds cannot be made:

1. If your transport (train/air etc.) is cancelled
2. No-shows, i.e. you don't cancel and you don't let us know that you won't be attending, or if you cancel at such short notice that we are unable to re-sell your place

3. Any illnesses —> **please purchase appropriate travel insurance to protect your investment.**

We reserve the right to cancel the retreat for any reason. This would only happen in exceptional circumstances resulting in us not being able to cover the retreat as advertised, or if the minimum number of participants to run the retreat is not met. Should this happen, we will notify you as soon as we have knowledge of the cancellation and will refund you the full amount you paid CBRC Health & Fitness, including the deposit. We cannot be hold liable for any expenses which you may have incurred, such as travel, holiday days or exchange rate losses.
